### SECTION 7. HANDLING AND STORAGE

7.1 PRECAUTIONS FOR SAFE HANDLING:

.1 PRECAUTIONS FOR SAFE HANDLING: Electrostatic charge may accumulate and create a hazardous condition when pumping and handling this material.
