- UNUSUAL FIRE AND EXPLOSION HAZARDS: With excessive heat, cans will rupture from internal pressure and discharge flammable contents. Vapors may ignite explosively. EFFECTS OF OVEREXPOSURE:

- Acute- High vapor concentrations are irritating to the eyes and the respiratory tract, and may cause headaches, dizziness, anesthesia, drowsiness, unconsciousness, and other central nervous system effects, including death. Product has a low order of acute oral and dermal toxicity, but minute amounts aspirated into the lungs during ingestion or vomiting may cause mild to severe pulmonary injury and possibly death.
  - Chronic- Xylene contains ethylbenzene which has been classified as a possible carcinogen to humans, Class 2B, by the International Agency for Research on Cancer(IARC), based on sufficient evidence in laboratory animals but inadequate evidence for cancer in humans. Prolonged or repeated overexposure to

ethylbenzene may cause the following: kidney effects, liver effects, lung effects, thyroid effects, testicular effects, pituitary effects.

PRIMARY ROUTE(S) OF ENTRY: Skin and Inhalation

EMERGENCY AND FIRST AID PROCEDURES:

- EYES: Flush immediately with large amounts of water for at least 15 minutes. Talk to a physician for medical treatment.
